**VILLAGE CHARTER ORDINANCE
NO. 2002-1**

A CHARTER ORDINANCE RELATING TO THE COMBINING OF THE OFFICES OF CLERK AND TREASURER, PROVIDING FOR THE APPOINTMENT OF THE CLERK-TREASURER AND PROVIDING FOR ANNUAL AUDIT OF ACCOUNTS OF THE VILLAGE OF NEW AUBURN.

The Village Board of the Village of New Auburn do ordain as follows:

Section 1: The Village of New Auburn, pursuant to Wis. Stats. §61.195 and §66.401, hereby elects not to be governed by those portions of Wis. Stats. §61.19, §61.25 and §61.26, which are in conflict with this Ordinance.

Section 2: The offices of Village Clerk and Village Treasurer are hereby consolidated and the duties of both offices shall be performed by the person appointed as Village Clerk-Treasurer by the Village President subject to confirmation by the Village Board, commencing on May 1, 2003. The incumbent Village Clerk and Village Treasurer shall continue to serve in their separate offices until the appointment and qualification of a Village Clerk-Treasurer. If a vacancy occurs in either office prior to the Clerk-Treasurer's appointment, the Village Board may appoint the remaining incumbent to perform the duties of both offices.

Section 3: The appointed Village Clerk-Treasurer shall hold office for an indefinite term, subject to removal as provided in Wis. Stats. §17:13.

Section 4: The Village Clerk-Treasurer shall perform all duties required of both the offices of Clerk and Treasurer as provided by law and those other duties as the Village Board directs to be executed by the Clerk-Treasurer from time to time.

Section 5: Annual audits shall be made of the records of the Clerk-Treasurer with the audit to be made by a Certified Public Accountant.

Section 6: All Ordinances or parts of Ordinances in direct conflict herewith are hereby repealed. All Ordinances imposing duties and responsibilities upon the Clerk, shall effective May 1, 2003, be performed by the Clerk-Treasurer, and all Ordinances imposing duties and responsibilities upon the Treasurer, shall effective May 1, 2003, be performed by the Clerk-Treasurer.


Section 7: This is a Charter Ordinance and shall take effect 60 days after its passage and publication unless within such 60-day period a Referendum Petition as provided by Wis. Stats. §66.0101(5), shall be filed, in which event this Ordinance shall not take effect until it shall have been submitted to a Referendum vote of the electors and approved by a majority of the electors voting thereon.



VILLAGE CHARTER ORDINANCE
NO. 2007-1

A CHARTER ORDINANCE REGARDING PRIMARY ELECTIONS

The Village Board of the Village of New Auburn do ordain as follows:

The Village of New Auburn, pursuant to the provisions of Wisconsin Statutes Section 8.05(4), 8.11(1), and 66.0101, hereby enacts the following Charter Ordinance:

1. Whenever five (5) or more candidates file nomination papers for the Office of Village Board Trustee, and whenever three (3) or more candidates file nomination papers for any other Village elective office, a primary election to nominate candidates for the office shall be held. The four (4) candidates receiving the highest number of votes for the position of Village Board Trustee, and the two (2) candidates receiving the highest number of votes for any other elective office, shall be nominated for such office.
2. All Ordinances or parts of Ordinances in direct conflict herewith are hereby repealed.
3. This Charter Ordinance shall be in full force and effect as provided under Wisconsin Statutes section 66.0101.


