Want to pay your water-sewer utility bill online? We contract with a 3rd party provider called AllPaid. Pay over the phone (888) 604-7888 or online at www.newauburn-wi.com. Available 24/7, 365 days per year. There are NO Fees using the web to pay your utility bill.

UPDATE & REMINDER About Leash Law In Effect Since 2022

New Code requires the same leash as the old code. Now refer to Chapter 133 Dogs and Other Domestic Animals, Section 133-8 Running at large. Paragraph (A), "No dogs, cats or other domestic animal shall, negligently or otherwise, be permitted to run at large within Village limits, which INCLUDES the Village Park. A dog, cat or other domestic animal shall be considered to be running at large if it is off the premises of its owner and not under the control of the owner or some other person." Furthermore, Paragraph (B) "All dogs shall be kept on a leash at all times when off the premises of their owner." Therefore, there should be no domestic dogs running around the Village. If we continue to receive complaints, we may ask the Sheriff's Dept to start issuing citations, if necessary. Thank you for respecting the Village's ordinances. We also ask you to be mindful of excessive barking Section 133-10 Barking, "No person, upon repeated complaints thereof, shall keep or harbor within the Village any dog or domestic animal which, by loud, frequent or habitual barking, yelping, or howling, shall cause serious and persistent annoyance to the neighborhood."

UPDATE Recycling Done Differently

New Auburn is now SINGLE STREAM recycling! That's right, you no longer have to separate plastics from paper or cardboard, or keep them in separate containers. Just one lift or drop into one of the recycling containers at the Refuse & Recycling Center at Village Hall during regular dump hours.

ATTENTION: GARBAGE cannot be thrown in with recycling. <u>PLASTIC GROCERY bags are NOT recyclable (these can be put in the multiple drop locations for the school).</u>

Chipping tree branches or brush is free up to 15 minutes. The chipper generally stops after 15 minutes unless the homeowner requests or authorizes them to continue. Any minutes after 15 will be charged back to the homeowner. Please stick branch butts out to the curb as this expedites the chipping process, and saves you any charges for any extended time beyond the 15 minutes.



AVOID UTILITY LATE FEES

Village Hall would like to remind everyone that utility payments are always due around the 25th of each month with exceptions made for holidays. We strive to post payments made on the due date or early the following day prior to assessing late fees. We know that many of our residents like to pay online with AllPaid because it's easy and convenient but you should know that if you pay on the due date or the day after, those payments do not post until the following day so to be safe and avoid late fees, please use the AllPaid option the day before the due date.

ALL dogs are required to be licensed per WI State Statutes. Show proof of rabies to get licensed at Village Hall.

Carbon-Rich "Browns"

Brown leaves & yard waste

- Brush & twigs (1/2" in diameter or less)
- Cardboard (dry and clean)
- Egg cartons (shredded)
- Newspaper
- Nuts & nut shells (but not black walnuts)
- Paper towels
- Pine cones & pine needles
- Sawdust & shavings (from non-treated wood)
- Straw & hay
- Wood chips

Nitrogen-Rich "Greens"

Green leaves & yard waste

- · Coffee beans, grounds & used filters
- Dirt & potting soil
- Egg shells
- Flowers & yard plants
- Fruit, including cores & rinds
- Grass clippings
- Gourds & pumpkins
- Melons and melon rinds
- Tea leaves & tea bags
- Vegetables, greens & legumes

NOT FOR COMPOST



Not for Home Composting

- Biodegradable forks, spoons & knives
- Branches or logs more than 6" in diameter
- · Charcoal briquettes or briquette ash
- Cigar & cigarette ashes
- Coffee or beverage cups
- Diapers
- Dairy products (butter, milk, cheese, etc.)
- · Invasive weeds and plants
- Meat (cooked or raw) & bones
- · Oils, greases & fats (including snack chips)
- Pet food
- Pet or human waste
- Pizza boxes with grease or cheese on them
- Recyclables (glass, plastic, metal cans. etc.)
- Sawdust from treated wood
- Trash (wrappers, packaging, etc.)
- Used take-out containers & Styrofoam shells
- Wood treated with varnish or paint
