AVOID UTILITY LATE FEES

Want to pay your water-sewer utility bill online? We contract with a 3rd party provider called AllPaid. Pay over the phone (888) 604-7888 or online at www.newauburn-wi.com. Available 24/7, 365 days per year. There are NO Fees using the web to pay your utility bill.

There's a Permit for that?

If you ask that question or even if you don't, please check before any building or remodeling work begins if you need a permit. We have had several individuals not get permits for their project and had to stop work until the permit was obtained. Did you know that if you do not get a permit, the fee for the permit is doubled? Village staff are here to help with any questions or issues.

UPDATE Recycling Done Differently - Also see attached information


New Auburn is now SINGLE STREAM recycling! That's right, you no longer have to separate plastics from paper or cardboard, or keep them in separate containers. Just one lift or drop into one of the recycling containers at the Refuse & Recycling Center at Village Hall during regular dump hours.

ATTENTION: GARBAGE cannot be thrown in with recycling. <u>PLASTIC GROCERY bags are NOT recyclable (these can be put in the multiple drop locations for the school).</u>

2025 Brush Pickup Schedule

Chipping tree branches or brush is free up to 15 minutes. The chipper generally stops after 15 minutes unless the homeowner requests or authorizes them to continue. Any minutes after 15 will be charged back to the homeowner. Please stick branch butts out to the curb as this expedites the chipping process, and saves you any charges for any extended time beyond the 15 minutes.

Battery Recycling Requirements For Households

Wisconsin has no legal requirements, with the exception of lead-acid batteries, for disposal of household-generated batteries. These include alkaline, lithium, lithium ion, metal hydride, nickel-cadmium, silver oxide and zinc-air. Batteries come in many sizes and can be rechargeable or single use. The Department of Natural Resources recommends recycling many battery types by taking them to a drop-off site. Batteries should never go in household recycling bins. For more information, or go to dnr.wi.gov and search "batteries.

Lead-acid batteries, or "automotive type batteries," are banned from disposal. Consumers may bring lead-acid batteries to any Wisconsin retailer that sells these batteries for recycling. This service is free to customers who buy a new battery. Customers may be charged a fee if they bring in a used battery without buying a new one.

Know the risk: how to prepare and store batteries for recycling


Many batteries, especially lithium ion, pose a fire risk due to their chemistries and ability to hold a charge. Batteries can spark and start a fire if their terminals touch metal or each other. The following recommendations can lower the risk of fire.

- . Put each battery in an individual, clear plastic bag, or tape each battery's terminals with clear packing tape.
 - . Store batteries in a non-metal container. . Store swollen or damaged batteries in sand or kitty litter.
 - . Keep battery labels visible. . Take stored batteries to a drop-off location frequently.
 - . Single-use alkaline batteries have little recycling value and may be safely thrown in the trash.

Batteries used in many households and office products, as well as motor vehicle batteries, contain a variety of heavy metals and other materials that can be harmful to human health and the environment if not handled properly.

ITEMS THAT CAN BE PLACED IN DROP-BOXES!

GLASS CONTAINERS:

- We accept glass food jars and bottles, and glass beverage containers for recycling
- Glass of all colors can be mixed together and placed in the same section in the recycling drop-boxes
- · Please remove caps and rinse out containers
- We do not accept any Porcelain or Ceramic, Crystal, Auto glass, safety glass, light bulbs or window pane glass for recycling

PLASTIC CONTAINERS:

- We accept #1 and #2 plastics for recycling
- Look at the bottom of your container to see what plastic it is made from
- · Please remove caps and rinse, no food filled items

TIN/STEEL CANS:

- Tin and Steel food cans can be recycled.
- Please remove labels and rinse cans clean

ALUMINUM CANS:

- · Aluminum cans can be recycled
- · Please rinse clean

CARDBOARD & MIXED PAPER

- At some drop-box locations we have bins for cardboard and paper recycling
- We accept any glossy print (like magazines or newspaper adds that are glossy), and bound books
- · We accept Cardboard, Newspapers, Copy/Printer paper
- Paper and Cardboard go in the same bin

ITEMS THAT MUST BE BROUGHT TO THE PROCESSING FACILITY IN ALMENA TO BE RECYCLED:

- 1.) Batteries: We recycle car batteries for free
- 2.) Light Bulbs/Ballasts: There is a fee to recycle bulbs and ballasts
- Appliances: There is a fee to recycle appliances, and appliances with Freon in them
- 4.) Electronics: There is a fee to recycle electronic items
- 5.) Yard Waste: There is a fee to recycle yard waste *see information on how to prepare yard waste on our Waste to Energy Department page at www.barroncountywi.gov

HELPFUL HINTS!

- Please do not place any food in our Drop-Boxes, they are emptied infrequently and this provides many sanitary issues.
 Many of the locations we have drop-boxes on are either public or private land, and we need to treat our neighbors respectfully!
- <u>Do not place plastic bags in the drop-boxes</u>, please empty your recycling items directly into the appropriate section

BARRON COUNTY RECYCLING ORDINANCE

- It applies to all of Barron County, EXCEPT the City of Rice Lake and Town of Rice Lake.
- It applies to all residences, multi-family residences, commercial and industrial entities
- It requires everyone separate and recycle the following items:
 - 1. Tin/Steel Containers
 - 2. Aluminum Containers
 - 3. Glass Containers
 - 4. #1 & #2 Plastics

Benefits of Recycling from the U.S. Environmental Protection Agency:

- By recycling our materials, we create a healthier planet for ourselves and future generations.
- Recycling reduces the need to extract resources such as timber, water, and minerals for new products.
- According to the most recent EPA data, the recycling and composting of municipal solid waste (MSW or trash) saved over 193 million metric tons of carbon dioxide equivalent in 2018.
- Recycling diverts waste away from landfills and incinerators, which reduces the harmful effects of pollution and emissions.
- Recycling provides a local positive impact on human health, property values, aesthetic, recreational values, and land productivity.
